Pursuant to the authority given under *Law Nr. 03/L-08, Amending UNMIK Regulation 2004/49 On the Activities of Water, Wastewater and Waste Services Providers*, of 13 June 2008 (“the Law”)

Based on the data provided with service tariff application by RWC “HIDROREGJIONI JUGOR” J.S.C. , and subsequent review and evaluation of this data,

In conformity with Section 15 of the *Rule for the Service Tariff Setting for Water, Wastewater Service Providers and Bulk Water Suppliers in Kosovo* of 12 August 2008 (WWRO Rule - R 02/W&WW)

Water and Waste Regulatory Office (“WWRO”) hereby issues the following:

SERVICE TARIFFS ORDER

ON SETTING TARIFFS FOR WATER AND WASTEWATER SERVICES TO BE APPLIED BY REGIONAL WATER COMPANY “HIDROREGJIONI JUGOR” J.S.C Prizren

1. Interpretation

In this Service Tariffs Order, unless the context requires differently, capitalized words and expressions shall have the meaning attributed to them in the WWRO Rule R 02/W&WW.

2. Applicability

This Service Tariff Order is applicable and enforceable to the RWC “HIDROREGJIONI JUGOR” in charging its customers for the Water and Wastewater Services provided throughout its designated Service Area.

3. Service Tariff Schedule

RWC “HIDROREGJIONI JUGOR” J.S.C. shall apply Service Tariffs to its Customers as per the Service Tariff Schedule as shown in the *Appendix 1* of this Service Tariffs Order.

4. Term

Service Tariffs approved under this Service Tariff Order shall entry into force as from 1st of January 2009 and shall remain in full force and effect until 31st of December 2011.

WWRO has the right to make regular and extraordinary corrections of the Service Tariffs on the request of RWC "HIDROREGJIONI JUGOR" in accordance with Section 16 of WWRO Rule-R 02/W&WW.

5. Publication and Distribution of Service Tariff List

5.1. RWC "HIDROREGJIONI JUGOR" shall distribute the Service Tariff Schedule as approved by WWRO under this Service Tariff Order to each Customer as applicable at the time of signing the Service Contract or at least once a year attached with Invoice.

5.2. The Service Tariff List as approved by WWRO under this Service Tariff Order shall be published by RWC "HIDROREGJIONI JUGOR" at least in one of daily newspapers of wide circulation in Kosovo, within seven (7) Business Days after the WWRO announcement and publication on the official WWRO web-site.

6. Appeals

RWC "HIDROREGJIONI JUGOR" has the right to appeal to the Review Committee established pursuant to the section 34 of the Law.

Official Language of the Service Tariffs Order

The Service Tariffs Order is issued and published in three (3) versions written in the official languages in use in Kosovo: (i) Albanian, (ii) Serbian, and (iii) English.

In case of any discrepancy between any of the versions, the Albanian version shall prevail.
