SERVICE TARIFFS ORDER

ON SETTING SERVICE TARIFFS FOR WATER AND WASTEWATER SERVICES TO BE APPLIED BY REGIONAL WATER COMPANY HIDRODRINI, PEJA

Pursuant to the authority given under UNMIK Regulation 2004/49 *On the Activities of Water and Waste Services Providers* of 26 November 2004 (“the Regulation”)

In conformity with Section 31 of the Rule for *Service Tariff Setting by Water and Wastewater Service Providers and Bulk Water Suppliers in Kosovo* of 26 January 2005 (“WWRO Rule R 02/W&WW”),

Water and Waste Regulatory Office (“WWRO”) hereby issues the following:

1. Interpretation

In this Service Tariffs Order, unless the context otherwise requires, capitalized words and expressions shall have the meaning attributed to them in the WWRO Rule R 02/W&WW.

2. Applicability

This Service Tariff Order is applicable and enforceable to the RWC HIDRODRINI hereby required to proceed in accordance with this Service Tariff Order in charging its customers for the Water and Wastewater Services provided throughout its designated Service Area.

3. Service Tariff Schedule

RWC HIDRODRINI shall apply the following Service Tariffs to its Customers:


